**ORDER CONSOLIDATING FOR TRIAL C.A. NO. N21C-03-257 EMD  
AND C.A. NO. N21C-11-082 EMD**

This 22<sup>nd</sup> day of December, 2022, for the reasons set out on the record at the hearing held on December 22, 2022,


**IT IS HEREBY ORDERED** that the Fox Corporation and Fox News Network, LLC’s Joint Motion to Consolidate is **GRANTED**.

**IT IS HEREBY FURTHER ORDERED** that the following conditions apply:

1. Fox Corporation (“FC”) shall:

- a. Provide complete responses to all outstanding discovery no later than 5:00 p.m. on January 9, 2023;
  - b. Produce all outstanding responsive documents no later than 5:00 p.m. on January 9, 2023; and
  - c. Produce all privilege logs no later than 5:00 p.m. on January 13, 2023
2. FC must make all deposition witnesses (as described during the December 21, 2022 hearing) available for deposition during the month of January, 2023.
  3. Fox News Network, LLC (“FNN”) and FC shall each submit declarations, under oath and penalty of perjury, certifying that all responsive documents have been produced. The respective declarations shall be signed by (i) a corporate representative of FNN and one of its attorneys of record; and (ii) a corporate representative of FC and one of its attorneys of record. The declarations shall be submitted no later than 5:00 p.m. on January 10, 2023.
  4. The Court will hold a status conference with the parties during the week of February 6, 2023. The counsel for the parties should contact my assistant by e-mail to schedule the status conference.
  5. The trial date, jury selection and pre-trial conference remain unchanged.
